What does your Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

Your Central Office responds to inquiries from stillsuffering alcoholics seeking help, from A.A. members seeking information about group meeting locations and time, from members of the professional community, and from the general public. We maintain a twenty-four-hour telephone answering service; we maintain a Twelfth Step volunteer list; we publish group meeting schedules; and we stock General Service Conference-approved, and A.A. Grapevine, books and pamphlets (many are available in Spanish).

We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, and with San Mateo County General Service District 5 and the Northern California Council of Alcoholics Anonymous, and we support, and participate in, many local A.A. events such as Sharingand Unity Days and the holiday Alkathons.

We maintain a web site, *aa-san-mateo.org*, with up-to-date group listings and meeting times, a calendar of A.A. events, and links to other A.A. web sites, and we maintain a library of CDs of A.A. speakers – they are available to be rented for a nominal charge.

We publish *High Sobriety*, sent at no charge to all San Mateo County A.A. groups and available by subscription to all A.A. members.

Who pays for our Central Office? We – the members of A.A. – do. Our Seventh Tradition states that we are self-supporting through our own contributions to Central Office; we also receive donations from individual alcoholics; and we derive income from the sale of A.A. literature.

Central Office now accepts credit cards!

Credit cards may be used for literature purchases, contributions, and will be available at the Central Office Party to purchase Silent Auction Items. A small fee will be applied.

The Ninth Concept

Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning and safety. The primary world service leadership once exercised by the founders of A.A. must necessarily be assumed by the Trustees of the General Service Board of Alcoholics Anonymous..

"No matter how carefully we design our service structure of principles and relationships, no matter how well we apportion authority and responsibility, the operating results of our structure can be no better than the personal performance of those who must man it and make it work. Good leadership cannot function well in a poorly designed structure Weak leadership can hardly function at all, even in the best of structures."

Due to A.A.'s principle of rotation, furnishing our service structure with able and willing workers has to be a continuous effort. The base of the service structure — and the source of our leadership — is the General Service Representative. The G.S.R. is the service leader for his or her group, the indispensable link between the group and A.A. as-a-whole.

Together the G.S.R.s are A.A.'s group conscience — and together, in their areas, they elect the area committee members and ultimately the delegates *and* the area's candidates for trustee. Groups who have not named G.S.R.s should be encouraged to do so. And as the G.S.R.s meet in area assemblies, care and dedication are required. Personal ambitions should be cast aside; feuds and controversies forgotten. "Who are the best qualified people?" should be the thought of all.

"No society can function well without able leadership in all its levels, and A.A. can be no exception. Fortunately, our Society is blessed with any amount of *real* leadership — the active people of today and the potential leaders of tomorrow as each new generation of able members swarms in. We have an abundance of

men and women whose dedication, stability, vision, and special skills make them capable of dealing with every possible service assignment. We have only to seek these folks out and trust them to serve us.

"A leader in A.A. service is therefore a man (or woman) who can personally put principles, plans and policies into such dedicated and effective action that the rest of us want to back him and help him with his job.


"Good leadership will also remember that a fine plan or idea can come from anybody, anywhere. Consequently, good leadership will often discard its own cherished plans for others that are better, and it will give credit to the source.

"Good leadership never passes the buck. Once assured that it has, or can, obtain sufficient general backing, it freely takes decisions and puts them into action forthwith, provided of course that such actions be within the framework of its defined authority and responsibility.

"Another qualification for leadership is 'give and take,' the ability to compromise cheerfully whenever a proper compromise can cause a situation to progress in what appears to be the right direction We cannot, however, compromise always. Now and then, it is truly necessary to stick flat-footed to one's convictions about an issue until it is settled.

"Our leaders do not drive by mandate, they lead by example. We say to them, 'Act for us, but do not boss us.'"

TRADITIONS CHECKLIST

From the A.A. Grapevine



These questions were originally published in the AA Grapevine in conjunction with a series on the Twelve Traditions that began in November 1969 and ran through September 1971. While they were originally intended primarily for individual use, many

AA groups have since used them as a basis for wider discussion.

Tradition Nine: AA, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve.

- 1. Do I still try to boss things in AA?
- 2. Do I resist formal aspects of AA because I fear them as authoritative?
- 3. Am I mature enough to understand and use all elements of the AA program—even if no one makes me do so—with a sense of personal responsibility?
- 4. Do I exercise patience and humility in any AA job I take?
- 5. Am I aware of all those to whom I am responsible in any AA job?
- 6. Why doesn't every AA group need a constitution and bylaws?
- 7. Have I learned to step out of an AA job gracefully—and profit thereby—when the time comes?
- 8. What has rotation to do with anonymity? With humility?

A Box of Pears

Her relationship with the mother who gave her up for adoption was chilly and distant until she heard Lisa's story in a meeting.

A few days ago, I was at a speaker meeting in which a woman named Lisa told her story. I didn't expect to hear anything more than I usually hear, which is always helpful in some small way. I didn't expect to be moved more so than I am usually moved. Lisa is half-Japanese. She grew up on Long Island. She is probably 20 years my senior.

There's nothing terribly similar about our lives, and nothing stands out to me now as the reason I was drawn to her immediately, but I was. Something about her face was familiar, kind. She started to tell her story, and I was captivated. I could identify, of course, with a lot of her childhood angst and discomfort, but it was more than that.

Before I got sober, I could never really hear anyone. Now I could truly listen to other people. So, I listened to Lisa. She told how at 17 years old she gave up a child for adoption. She described the feelings she had after she gave birth and the child was taken from her.

She something like, "I felt that all the air had been taken out of me, away from me. I felt empty and alone. I was confused and afraid. I didn't know how to do anything, how to live."

I really heard her. I heard her, and I understood what she'd felt in those terrible moments. And I cried. I tried to dry my tears with one finger, instead smudging the mascara under my eyes. Lisa continued with her story.

I raised my hand to share. I don't share very often—not because I don't have joy to share or sadness for which I need support, but because I really do love to listen to my fellows. But this time, I felt a powerful need to share.

I told Lisa and the group that she had given me a great gift: the gift of sympathy.

I told her that when I was an active alcoholic, I never felt sympathy. I never felt anything. Alcohol had numbed me for so many years. I didn't even understand what other people meant when they said they felt sympathy or empathy. I knew how to behave as if I felt those same things, but I didn't really feel them. I had, for various powerful reasons, kept feelings at a distance.

I explained to Lisa, and to the group, that my biological mother, who had given me up for adoption at birth and whom I had never known, had tracked me down some years ago.

I had seven Bloody Marys before meeting her. She'd found me, and I was angry. She'd found me, and when we met, she asked me to forgive her, and I didn't say anything. I held on to my anger for a while, and then I let it fade into indifference. I let the relationship become one of occasional e-mails and the box of pears I sent her at Christmas.

Not once in the years since she found me—her name is Leslie—had I thought about what she had gone through when she gave me up. Not once did I try to put myself in her shoes.

And then, I heard Lisa's story. I thanked her for that very precious gift, and I thanked the group and AA for giving me the ability to accept this gift.

I cried. A lot. That evening, I wrote to my biological mother. I told her the whole story. I told her of my anger when she tracked me down, and I told her of my gratitude for AA and for Lisa. This is some of what I said to her in that letter:

The truth? Being adopted has affected me in many ways, both good and bad. But I'm not writing to you about that today. I'm writing to you to say thank you for making the difficult choice to put me up for adoption. I am so grateful for the life I have had as a result. Until yesterday, I knew it had to have been difficult, but I never fully grasped the pain and fear you must have felt.

So, there's this part of me now that wants to say, 'Let's really get to know each other.' There's this part of me that wants a hug from you so much, and to hug you right back.

But there's this other part of me that is afraid. I am afraid. But I suppose I hope we can make some small steps forward. Maybe we can just start to email more often and maybe talk sometimes on the phone.

I would never have written that letter had I not learned about listening to other people and feeling sympathy for their circumstances.

A Higher Power Story

When I came into the Program, I had a God. It was a "church God", and for years it had been nurtured and served me faithfully. I soon discovered that it was inadequate to serve as my Higher Power in AA.

So I developed a new "higher power model" to support me in my recovery. I still call it God, but it is different-and bigger-than my previous one. I believe my Higher Power talks to me, if I will listen, and while not revealing His plan for my life, will give me insights into specific situations in my life as they occur. Or, when I am doing non-listening things, like driving down the freeway, He will also give me insights into my life.

One such situation occurred several years ago (you will see how long ago, when I relate the particulars) while I was on my way to Hawaii. Since I travel "Space Available"(standby) I was boarded after the rest of the passengers and made my way to my aisle seat in Economy. The middle seat was empty, and in the window seat there was a young woman. She was dressed warmly in a hoodie and blue jeans, unusual for someone going to a tropical climate. She watched me sit down, fasten my seat belt, get out my "work kit" for the flight, about 3 inches of paper I planned to sort through in the next 5 hours, and stow the rest of my carryon under the seat.

"You must fly a lot," she remarked. "I don't like the takeoffs and the landings." "Yes," I acknowledged, "but that's why we pay the pilots the big bucks." That seemed to reassure her, but I noticed as we accelerated down the runway, she gripped the seat arms in a tight grip. I put my hand on top of one of hers, and she relaxed, a little. As we climbed to our cruising altitude, she extracted her hand and went back to one of the self-help books she had brought with her. I started working on my paperwork.

After about an hour of silence, she put down her book and turned toward me. "Do you believe in God?" she blurted out.

But then, into my head, came the small, still voice of my Higher Power (God), asking me, "Why not?".

I thought, oh no! Lady, I don't know you from a sack of potatoes, and you're asking me to share about my personal God? I've got other things to do on this flight, and I'm on vacation. Why should I respond to this question? But then, into my head, came the small, still voice of my Higher Power (God), asking me, "Why not?".

So, I said, pointing past her out the airplane window, "How could you see that and not believe there is a God"? Outside the airplane we were slowly passing next to a bunch of thunderheads, probably 10,000 feet in height, big and great, and beautiful. She looked out the window, nodded, and went back to her book.

Soon it was time for lunch, and that will date this experience because the airline was serving meals instead of snack boxes and popcorn. As we started to eat, she shared with me what was going on in her life.

Her father had had a major heart attack on Maui. They had evacuated him by helicopter to Honolulu, and were trying to stabilize him so they could do bypass surgery. The prognosis was not good. Her stepmother was there. Her brother had already flown over. They had called her to come. She and her stepmother didn't get along well. Her minister had given her the self-help books to read.

After we landed and were walking up the jet way, I asked her if anyone was meeting her. "No." she said, a little forlornly.

I told her I was staying on the northeast corner of the island (at Kaneohe Marine Corps Base) and added, "Wherever the hospital is, I probably have to pass by it to get to where I'm going. Could I give you a ride?"

She agreed, and while she was powdering her nose, I looked up the address of the hospital she had given me, and satisfied myself I could find it with my limited knowledge of downtown. We rode there in silence, and I stopped across the street from the hospital. When she had gotten out of the car, I asked her if I could pray with her. She brightened a little, and nodded yes. I gripped both her hands in mine, and right there in the street, prayed. I prayed for her father, and that he would be strong enough to make it through the surgery. I prayed that the surgeons would have the skill to repair his heart. I prayed for her, and that she and her stepmother would find common ground during this period. And I even prayed for her damn brother, who wouldn't pick up his sister at the airport!

She started to cry. I waited a little, then said, "You are going to come through this all right, because you are a child of God."

She picked up her suitcase, walked across the street, and vanished through the door of the hospital. I never saw her again.

So what does this have to do with us, as members of AA? I think two things:

- -We rarely get a chance to be of major service to an individual, as I believe I had been to her.
- -Every day, there are countless small opportunities to be of service to other members of the program, or to other individuals.

The Gate Agent could have seated me anywhere on the airplane, but he placed me next to her. Was this a coincidence? I don't believe so. Since I came into the program, I don't believe there are coincidences any more. I believe it is my Higher Power working in my life (which rarely happened with my "church God.")

So the next time you have an opportunity to be of service, ask yourself, "Why not?"
