## What does our Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

* Maintain a 24/7 telephone line which responds to inquiries from still-suffering alcoholics seeking help, A.A. members in need of information, and from members of the professional community and the general public. After office hours, this line is staffed by Teleservice volunteers.
* Maintain a Twelfth Step volunteer list.
* Maintain and publish group meeting schedules; in print, on our website, and in the Meeting Guide App.
* We stock a large selection books and pamphlets for sale (many are available in Spanish).
* We offer sobriety chips for sale, for both individuals and groups.
* We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, as well as with San Mateo County General Service District 5 and the Northern California Council of Alcoholics Anonymous
* We support and participate in many local A.A. events such as Unity Day and the holiday Alkathons.
* We maintain our web site, aa-san-mateo.org, with up-
* to-date meeting listings, a schedule of A.A. events, the High Sobriety newsletter, and links to other A.A. web sites,
* We maintain a library of A.A. speaker CDs which are available for rent for a nominal fee.
* We publish the newsletter, High Sobriety, sent at no charge to all registered San Mateo County A.A. groups and available by subscription to all A.A. members. Faithful Fivers receive a free copy as well.

Who pays for our Central Office? We, the members of A.A., do. Our Seventh Tradition states that we are self-supporting through our own contributions. Central Office also receives donations from individual alcoholics (such as through our Faithful Fivers program). Other sources include our annual anniversary party and income from the sale of A.A. literature.

Central Office is open M-F from 8:30 am to $4: 30 \mathrm{pm}$ (open Wednesdays until 6:00 pm).

## Where's Waldo?

## Step Seven - Humbly asked Him to remove our shortcomings.

If you have ever been to Venice, California, you know it is a beautiful place for sun, fun, and drinking. When I moved there in 1977, I was singing in a band and living the life of a drunk. By 1980, I was living in squalor in a canal apartment, never breathing a sober breath. It took me three years to finally get to a meeting of Alcoholics Anonymous and one more to get my first day of sobriety.

One morning at a 6:45 meeting, I heard a man named Israel share, and my life changed. I got his phone number and started to call him. He told me the answer to all my problems was in the pen. He suggested I write this: "Dear God, I have a problem and I can't solve it alone. The problem seems to be----." He suggested I keep writing and see what happens.

At the end of putting pen to paper, I'd write, "Please remove my fear and resentment and replace it with the knowledge of your will for me and the power to carry it out." After doing that, I would call him, read what I had written, and then throw the paper away. He would say, "Now it's God's problem." Well, needless to say, I was on my way to freedom.

Still, there was a nagging little voice in my head eating me alive. Israel said, "You have to give that voice in your head a name and make friends with it, or it's going to kill you."

So I named the voice Waldo. One day, when I was ranting about something of little importance, my roommate asked, "Is that you or Waldo speaking?" That's when the name stuck.

Waldo usually is up before I am. When I wake up, he is at the chalkboard in my head, making a list of all my fears, which will come to pass as soon as my feet hit the floor. With the help of my sponsor, I have found that saying the Seventh Step and Third Step prayers is an excellent way to start the day and send Waldo back into his hole to plan his next speech, or at least quiet him down. When I sleep, Waldo is at the gym doing heavy lifting, preparing a new game plan to lead me to the next drink. He has an endless supply of fear, delusion,
and self-deception, and whenever the smallest opportunity appears, he is right at the podium in my head desperately trying to get my attention. Sometimes he succeeds, and my life becomes dark, sad, and hopeless until I take the steps necessary to quiet his relentless struggle for control of my body and mind.

Putting pen to paper and writing a letter to God are the first step. I also made up a little prayer, and I say it in threes: "I am safe and God is with me; I am safe and God is with me; I am safe and God is with me." Take a breath. "I am safe and God is with me; I am safe and God is with me; I am safe and God is with me." Take a breath. . .and so on, until Waldo creeps away.

I have found a tremendous freedom in getting to know the sound of Waldo's voice. He has been my friend for fifteen of my eighteen-plus years of sobriety. When I follow Waldo's advice, I generally can count on a nasty roller-coaster ride. When I put pen to paper and take a physical action to change my emotional state, the healing is instant--every time so far.

## A.A. Around the World Stepping Up

On March 2, 1999, the first meeting of the Freedom Group of AA was held in Granville Hall, Annapolis County, Nova Scotia. Attendance was twelve men and women, the topic was Step One, and the hat yielded about fifteen dollars. It had been decided that the group format was a closed Step discussion meeting. How the need for such a group was identified may be of interest.

In this rural area, the population is not dense, and the existing groups are quite widely scattered. While it is possible to attend a meeting every night of the week, a drive of some twenty to forty miles might be necessary depending on your starting point. Most of these meetings are of the closed discussion variety, and most host an open speaker meeting once a month to celebrate birthdays and
anniversaries. There are in addition, governmentrun detox and short-term care facilities that offer exposure to AA. Many of the newcomers to local AA groups are referrals from one or both of these services.

It is a fact of our AA life in this area that there is a lack of continuous-attendance members with middle (ten to fifteen years) and long-term (twenty years plus) sobriety. This results in meetings where many can share experience in sobriety with a problem such as anger, dishonesty, boredom, Ioneliness, financial insecurity, etc., but few at the table are able to share the strength and hope that are available for the successful resolution of these situations. This lack of recovery experience precludes discussion of the program of recovery itself. Thus, many meetings can take on a feeling of sameness and there is represented little of the vitality of this "Great Adventure," of coming to grips with the realities of our strengths and weaknesses. Few are the experiential insights gained in the attempt to "take" or "work" the Steps, and thus many nights end with little or no positive direction which the struggling newcomer might profitably follow.

It was this situation, therefore, which prompted some of us who bear the scars of sobriety to contemplate the founding of a group where the topics would simply be the Twelve Steps in order to present the program which is suggested as the way out from the myriad problems associated with a life of alcoholic drinking. It is our hope to pass on an understanding of such words and expression!s as "powerlessness," "surrender," "one day at a time," "acceptance," which is crucial to the understanding of the fundamentals of recovery itself. We wish further to reassert that, so far as we know, the only remedy still available to the alcoholic who wants to stay stopped is daily abstinence, one day at a time, and that the power to do this is readily available for the asking. This is not to offer any opinion on any of the advances made by the sciences relative to our understanding of this still terrible disease. We are,
however, determined to assist those coming behind through their "desert" years, when problems emotional, physical, spiritual, or mental begin to dim the luster of the hard-won early sobriety, and explanations scientific and laborious are powerless to provide any relief. Those of us who have "been there, done that" try to ease the pain by specific sharing of similar or exact experience. Our simple presence in the discussion, and our sharing, offer proof positive that "this too shall pass," regardless of what the "this" is.

And so the Freedom Twelve Steps Discussion Group has started, with the simple aim of focusing the discussion on our shared program of recovery. There appears to be some initial enthusiasm, and depending on the commitment of the group members to conduct their affairs in accordance with our Traditions, there is every expectation that the group will survive. It is a good feeling to be a part of it. Something of importance is once again happening when, "in the middle of the darkest night," the good news is shared with those who need it.

## MALE CALL

## Looking for sober men to sign up for Corrections Correspondence Service

The General Service Office (GSO) has an urgent need for AA men to write inmates in English or in Spanish through the Corrections Correspondence Service (CCS). GSO has a waiting list of male AA members in prison who are waiting for an outside AA member to write to them. (Female AA members in prison can get linked right away, thanks to all the female volunteers who have signed up.)

CCS is not a traditional pen pal service that may involve financial support or letters of reference. This service offers the opportunity for AA members on the inside and the outside to share experience, strength and hope with each other via postal correspondence. GSO only makes the initial connection, which is a random match between inmates with a drinking problem and outside AA members of the same gender who live in another region or province away from that correctional facility. Once an initial contact is made through a letter, it might be possible to continue the CCS electronically (messaging, email), if available through the facility.

The CCS does not assign sponsors, but an outside AA member may be willing to sponsor after contact is made. Because correctional facilities often have rules prohibiting direct contact among local AA volunteers and inmates, the letters exchanged through CCS from another region might provide an alcoholic behind the walls with his or her only personal connection to another AA member. Outside AAs can share their experience to guide an incarcerated alcoholic through the Twelve Steps of AA, or can just answer basic questions about AA's program of recovery.

GSO says that participants on both sides of the CCS rave about the value of this kind of letter writing with other alcoholics. The inmates share that they find freedom even while behind walls, and the outside members deepen their own connection to AA and their understanding of the Twelve Steps. No prison experience is needed. Those with clearance issues are welcomed. Mail call means everything for those incarcerated. One-on-one sharing helps both insiders and outsiders who participate in this very valuable program.
