To find a list of online meetings in San Mateo County, there is a new menu heading at the top titled "Online Meetings". If you are looking at a mobile device, this can be found by pressing the icon with 3 horizontal lines in the upper right corner of the screen. ≡

There is also now a page, also accessible from the top menu, for managing online meeting participants and for best practices for a digital 7th Tradition, if your group chooses to do so.

# What does our Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

- Maintain a 24/7 telephone line which responds to inquiries from still-suffering alcoholics seeking help, A.A. members in need of information, and from members of the professional community and the general public. After office hours, this line is staffed by Teleservice volunteers.
- Maintain a Twelfth Step volunteer list.
- Maintain and publish group meeting schedules; in print, on our website, and in the Meeting Guide App.
- We stock a large selection books and pamphlets for sale (many are available in Spanish).
- We offer sobriety chips for sale, for both individuals and groups.
- We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, as well as with San Mateo County General Service District 5 and the Northern California Council of Alcoholics Anonymous
- ❖ We support and participate in many local A.A. events such as Unity Day and the holiday Alkathons.
- We maintain our web site, aa-san-mateo.org, with up-
- to-date meeting listings, a schedule of A.A. events, the High Sobriety newsletter, and links to other A.A. web sites,
- We maintain a library of A.A. speaker CDs which are available for rent for a nominal fee.
- We publish the newsletter, High Sobriety, sent at no charge to all registered San Mateo County A.A. groups and available by subscription to all A.A. members. Faithful Fivers receive a free copy as well.

Who pays for our Central Office? We, the members of A.A., do. Our Seventh Tradition states that we are self-supporting through our own contributions. Central Office also receives donations from individual alcoholics (such as through our Faithful Fivers program). Other sources include our annual anniversary party and income from the sale of A.A. literature.

# **Cleaning House**

My dictionary defines the word "moral" as "right and wrong in behavior," and "teaching a conception of right behavior."

I was always able to define everyone else's wrong behavior. Not until I walked into the rooms of AA was I aware that I needed to define my own moral behavior. What a revelation! I continued to take everyone's inventory, with the exception of mine. AA's Fourth Step helped me. It taught me to realize that in all my dealings with people, I also had a part of every situation. Never did I realize that before. Even if someone else was 99% wrong, I, too, was responsible for my 1% in dealing with that situation. What an eyeopener. Until I found out this piece of information, I was usually playing the role of the victim, caretaker or controller. My thinking changed. The life I live now is so much easier. I have peace that I never experienced before coming to the rooms of AA. I am also grateful that I do not have to do this all alone. The help of my sponsor, the rooms of AA and God have given me much joy. And to know that I am not alone makes this cleaning house so much easier.

The Fourth Step gives me the availability and opportunity to see my part in each and every situation of my life. I have a map now to help me travel on "the road of happy destiny." It's a much smoother and easier way to live. The ability to see how my actions and behavior in each and every situation is played out is so helpful to me. And not until I understand what my part is, can I go forward. I have gratitude for Step Four because it allows me to no longer brood over situations that used to baffle me, to not drink over things and to not be the victim I was when I came into AA. God, my sponsor and the rooms of AA have given me a life that is certainly worth living.

# **Letter from Spain**

# An AA from Gijón, on Spain's northern coast, shares his story with Grapevine readers

I grew up in a small town in the northern coast of Spain. Memories of my childhood mostly consist of the constant fights between my father and my mother. There were a lot of money issues because of my father's partying and gambling. I remember my father lying on the living room floor sleeping. Sometimes, he sent me to the bar to buy snuff or buy cokes for my brothers and sister and me. I remember when I was eight years old, we received a letter telling us to vacate our home within 15 days. My father had spent the rent money playing cards.

I started drinking when I was 14 years old at home with family. That was not unusual in Spain in the eighties. When I started drinking, it was an occasional activity and I really liked it. The occasional became the common within a couple of years. I started drinking in the morning. When I was 17, I went on a true binge that began at the school Christmas party. I still remember how sick and hungover I felt afterward.

Two months later, at Carnival, I got very drunk and blacked out. I had a bruise on my forehead next day.

I drank every day and frequently got drunk for the next seven years. I did odd jobs to afford my drinking. Eventually, my family forced me to visit a psychologist. This did not solve my drinking problem. I drank "moderately" for about six months until November. Then I got drunk at Halloween, at Constitution Day (December 6 in Spain), at Christmas, at New Year's Eve, and at the Epiphany.

On the Epiphany, January 7, I started drinking in the morning. I got drunk in record time. The

next day my sister told me that I was drinking more and more every day and that our family couldn't endure it anymore. I decided to go to Alcoholics Anonymous the next day.

I went to AA on a Monday afternoon. I had to wait five minutes for them to open the meeting. The man who opened it up gave me some pamphlets and told me the group timetable. I went into a large and cold room. Nobody really explained things to me.

People listened to the newcomers like me like they listened to the rain.

When the meeting ended three or four of us had coffee. It was not until several months later that I learned how things worked. Many newcomers did not continue going but I did.

I was doing some service in the group, reading the texts, making coffee, and helping the group out. I had been nine months in the group when I started to study again, and I visited a group in another town. I was welcomed there and felt that they listened to me, so I decided to stay in that group.

Several years passed and I stayed there, doing service and remaining sober. One Sunday afternoon, out of the blue I fancied a beer. I drank several. Shame prevented me from recognizing openly what has happened. About 10 years later, the same thing happened again only this time, I understood it to be a relapse.

Now, I have several years without a drink. I keep going to the weekly groups and I like to go to AA conventions.

# ATTEND A MEETING ONLINE, HERE'S HOW.

# PREPARING TO USE ZOOM FOR ONLINE MEETINGS

- 1. You can use Zoom from a smartphone, a tablet or a computer. But first, you must download and install the Zoom app:
  - iPhone and iPad users should visit the Apple App Store to download and install the Zoom app on their device. Android users should visit the Google Play Store to download and install the app.
  - If you are using Zoom from a desktop or laptop computer, download the Zoom app by visiting <a href="https://zoom.us">https://zoom.us</a>, then select Resources located at the top of the page, and select Download Zoom Client. Finally, click or tap the blue Download button under Zoom Client for Meetings and select Run when prompted.
- 2. Regardless of whether you are using a smartphone, tablet or computer the second step is to create a Zoom account:
  - Within the Zoom app select Sign Up and follow the prompts.
  - After you have entered your email address and name (and agreed to the terms), Zoom will send you an email. Open the email and click or tap the blue button that reads **Activate Account**.
  - At this point, you will be asked to select a password. Setting a password is the last step in creating your Zoom user account.
  - Finally, sign into your Zoom account.

# ATTEND A ZOOM ONLINE MEETING

- To join a meeting, you must first locate a meeting. Find one by visiting
   https://sites.google.com/view/bayareazoomaameetings to see a list of the available Zoom meetings arranged by day of the week.
- 2. Locate an online meeting that meets on the day that you would like to attend. Online meetings are held the same day and time that its corresponding face-to-face meeting is regularly held.
- 3. Click or tap the **Join Zoom Meeting** link for the meeting that you would like to attend. Doing so will automatically launch the Zoom app that you previously installed. You will be in the Zoom meeting that you selected, and you will be able to see your fellow meeting attendees.

**NOTE**: Please keep in mind that people will be able to see your surroundings as well as hear what is going on around you. As a courtesy, please **mute** your Zoom app while you are not speaking.

# Frequently Asked Questions About the Cancellation Process for the 2020 International Convention

## Q: Will my registration be refunded?

A: Yes, registration fees will be refunded in full within 6 weeks. The \$5 cancellation fee will not be charged.

We ask for your patience and request that you not call the registration company directly until at least 6 weeks have passed to allow time for refunds to be processed.

Credit Cards: If you paid with a credit card, that card will be credited directly. If you no longer have the credit card used during registration, you will be refunded by check.

Checks/Money Orders: If you paid with a check or money order, a refund check will be processed and mailed to your address.

If you canceled your registration and were charged the \$5 cancellation fee, the charge will be refunded to you.

#### Q: Will my hotel reservation be canceled and deposit refunded?

**A:** Yes, your reservation will be canceled by the Housing Bureau and you will receive a confirmation of the cancellation. If the hotel has charged their deposit, you should receive a refund of the full deposit by April 30, 2020. If you do not receive your refund by April 30, 2020, please contact the hotel directly. #### Q: I rented a scooter or wheelchair, will that reservation be canceled and refunded?

A: Yes, your reservation will be canceled and refunded within 8-10 weeks.

#### Q: Were all 2020 International Convention ancillary events slated to take place in Detroit canceled?

**A:** All events scheduled as part of the agenda of the International Convention have been canceled including the Al-Anon portion of the International Convention and the Thursday evening Party in the Plaza.

#### Q: What happens to the souvenir book I purchased?

A: If you purchased one or more souvenir books while registering, the credit will be added to your total refund.

# MANAGING MEETING PARTICIPANTS


Just as in the physical rooms, meetings on Zoom feature resentments, ringing phones, and other disturbances. In fact, some SF/Marin groups, particularly women's meetings, are experiencing sexually predatory and violent behavior from meeting participants.

While this, too can happen in physical meeting rooms, the anonymity of the internet provides a shield for the predators. Fortunately, while not possible to maintain absolute security, there are a number of features available to handle the more disruptive participants.

# **Set Safe Meeting Default Settings**

On the Zoom Settings page, turn off participant controls:

- 1. Sign into Zoom.us.
- 2. Click on the Settings link on the left.
- On the right side of the page, turn off:
   Autosaving chats, file transfer, screen sharing, virtual background, and remote control.



### Identify a Meeting Secretary AND a Co-Host

For starters, elect a co-host whose role is to shoulder the weight of maintaining order during the online meeting by managing the participants. This allows the meeting secretary to focus on the meeting, while the co-host focuses on managing participants and the meeting controls. Co-hosts are assigned during a meeting and cannot start a meeting.

## Assign a Co-Host

- 1. Sign into Zoom.us.
- 2. Click on the Settings link on the left of the screen.
- 3. Scroll down to the Co-host option on the Meeting tab and verify that the setting is enabled.
- 4. Turn on Co-Host. If a verification dialog displays, choose Turn On to verify the change.


#### Manage Disruptive Participants During a Meeting

The Meeting Participants window offers control over most aspects of your meeting and those attending. Zoom has a <u>10 minute long video</u> (https://support.zoom.us/hc/en-us/articles/201363183-Managing-users) that is recommended viewing for all meeting secretaries who host meetings and anyone who plans to co-host a meeting at any time.

# MANAGING MEETING PARTICIPANTS, cont.

# **Remove Participants**

1. During the meeting, click **Manage** to display the participants list.



During the meeting, a host can see More and Mute All

Controls at the bottom of the Participants list.

1. On the Participants List, click Lock Meeting to prevent other participants to join the meeting in progress.

# **Muting All Participants**

During the meeting, a host can see More and Mute All Controls at the bottom of the Participants list.



1. On the Participants List, click Mute All to mute all meeting attendees.

# **Suggested Other Zoom Features**

- 1. Consider enabling the Waiting Room for your meeting. You then play an active role choosing who to allow into the room through the participants list.
- 2. Consider disabling Join Before Host to keep users out before the host arrives. When "Join Before Host" is enabled anyone can enter at anytime.
- 3. Consider restricting In-Meeting Chat to reach only host only during the meeting. Many meetings open it up for fellowship after the meeting.

# Other Suggestions for Setting Up Meetings to Keep Safe from Disruptive Attendees

You can also take a group conscience regarding screen sharing, mute and unmute privileges, chat settings among participants and more.

Zoom default:

- 1. Login to Zoom.us
- 2. Click on Settings.
- 3. Click on the Meeting subtab.
- Scroll through the options in In Meeting (Basic) and In Meeting (Advanced) and change the following settings:
  - Require Encryption for Third Party Endpoints
  - Disable Auto saving chats
  - Disable File transfer
  - o Disable Feedback to Zoom
  - Disable Screen sharing
  - Disable desktop/screen share for users
  - o Disable Remote control
  - Disable Virtual background (While fun, some trolls have been showing up to online meeting with violent and pornographic images as their background.)
- 5. In the Zoom Settings section, under the Recording subtab:
  - Disable Local recording
  - o Disable Cloud recording
  - Disable Automatic recording
- Hold a steering committee meeting using a private link sent to the meeting's phone list. Take a group conscious on how to secure the meetings and keep them safe.
- Ensure that all meeting secretaries have access to Host controls so they can take control of the meeting when the safety of the members are compromised.
- Train the host/secretary on how to kick out attendees who become disruptive.
- For closed meetings: Consider using a private Zoom meeting link for the meeting and send only to phone list members.
- Newcomers: Consider hosting newcomer meetings with public links, but enable the Waiting Room, so the host/secretary has to allow everyone in the meeting.
- CPIC Committees or H&I Reps Consider reaching out to local rehab centers and let them know about new safety protocols.

I hope you all are safe and healthy during this challenging time. In consideration of the current public health recommendations, there have been several changes to our usual General Service schedule and upcoming AA Events.


- The virtual Pre-Conference Assembly has been postponed to May 16 & 17 to allow for more time to gather group consciences and dive deeper into the Agenda Topics.
