What does our Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

- Maintain a 24/7 telephone line which responds to inquiries from still-suffering alcoholics seeking help, A.A. members in need of information, and from members of the professional community and the general public. After office hours, this line is staffed by Teleservice volunteers.
- Maintain a Twelfth Step volunteer list.
- Maintain and publish group meeting schedules, in print, on our website, and in the Meeting Guide App.
- ❖ We stock a large selection books and pamphlets for sale (many are available in Spanish).
- We offer sobriety chips for sale, for both individuals and groups.
- We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, as well as with San Mateo County General Service District 5 and the Northern California Council of Alcoholics Anonymous
- ❖ We support and participate in many local A.A. events such as Unity Day and the holiday Alkathons.
- We maintain our web site, aa-san-mateo.org, with up-
- to-date meeting listings, a schedule of A.A. events, the High Sobriety newsletter, and links to other A.A. web sites,
- We maintain a library of A.A. speaker CDs which are available for rent for a nominal fee.
- We publish the newsletter, High Sobriety, sent at no charge to all registered San Mateo County A.A. groups and available by subscription to all A.A. members. Faithful Fivers receive a free copy as well.

Who pays for our Central Office? We, the members of A.A., do. Our Seventh Tradition states that we are self-supporting through our own contributions. Central Office also receives donations from individual alcoholics (such as through our Faithful Fivers program). Other sources include our annual anniversary party and income from the sale of A.A. literature.

Pause Before You Send

She found that her computer was not the best place to do a Ninth Step.

Recently, I had a weird experience. I was talking with an old friend, Susan (not an alcoholic), from New York on Facebook about how we met. We had both been on a trip to England after high school in 1980, called "Drama in Britain." And yes, it was drama—mainly because I was there. I was doing my thing that I would do: becoming best friends with you for two or three days and then starting to hate you and telling all your secrets to the people I had been character-assassinating to you for the last three days—and then of course, wondering why everyone hated me. Poor me. And of course I was drinking, cuz that's what I do when you hate me and I feel bad. I'd act like a jerk, polish up my alibis and then go get drunk.

Well, I've since made amends to my friend Susan, and she and I were discussing the other people in the group, and we remembered our friend Sandy. Susan said she wanted me to find Sandy, so I went on Google and looked her up. I found a newspaper article that said she had gotten married to a famous movie producer, hyphenated her last name and now lives in Los Angeles. Hmmm... she's rich, maybe she'll buy some of my artwork, I thought. (I am so self-seeking.) So I looked her up using her married name, and I found her—on Facebook! I got to her page, and just before I was about to click "Friend," I had a thought: I owe her an amend. Oh no!

I don't know about you guys, but I hate amends. I made all the amends I could find in my first inventory, and I stand ready to make amends when they show up. I loved the process when I was in it back then, but when amends show up now, I'm not happy about it. But I do it, because I have to, because I never want to drink again, and because I like the freedom I have today, and I know that freedom is contingent upon some conditions that I have to meet and maintain.

Well ... God gave me the moment to pause before I clicked "Friend." And I did not listen. I clicked "Friend." Had I paused, I might have had the

opportunity to make a proper amend. I know that now.

Sandy wrote back that she was amazed to hear from me. She wanted to know how I was and what had been going on the last 30 years. I should have paused.

I called my sponsor (better late than never) to discuss this. My sponsor doesn't use Facebook. He is an old-school dude, and so am I, really. I only have a page up because a marketer told me I have to have a presence on it to sell my art these days. I am not even sure that is true.

And of course I was drinking, cuz that's what I do when you hate me and I feel bad. I'd act like a jerk, polish up my alibis and then go get drunk.

As it turned out, I ended up having to make the approach on Facebook. Sandy did not give me her phone number, and she stated that she didn't remember what I had done. Now, I have learned that I am not going to re-harm the person by discussing in detail what I did if they don't remember, so my sponsor and I figured out a benign way for me to say it to her, and if she wanted to talk about it further, we could.

The problem was that it happened on Facebook. Maybe I am the only one out here making mistakes like this, and maybe my mistake can save the rest of you some grief. Maybe you guys are way smarter than me and would never do something this stupid—I don't know.

The Ninth Step says that we make direct amends to such people wherever possible. And there is nothing less direct than email, Facebook and texting, in my experience. There are no facial expressions, there is no eye contact, no vocal inflection and no spiritual interchange, which is what creates the forgiveness and transformation of an amend.

I did what she asked for. I gave her the vague version of what I did and a rundown of the last 30 years, hoping she would write me back and give me her number so we could talk—but nope. Without the spirit there is nothing, and so Sandy never wrote me back.

I was left with a hole in the pit of my stomach and an experience to share with you and my sponsees of what not to do. I know my sponsees are going to find people on social networking sites, but my suggestion is going to be that they see if they can find out what city the person is in and then try to get an address and a phone number.

The sad thing is, I had gotten Sandy's address and phone number before I clicked "Friend." I was just too impatient to wait.

A.A. Around the World

The Little Group on Hapalmach Street

In Jerusalem, an old meeting room disappears, but not the years of love.

One of the wonderful things about Alcoholics Anonymous is that we don't have monuments. It's a spiritual program, and the only requirements for a meeting are a coffee pot and a couple of ex-drunks with a resentment, they used to say.

Change is inevitable and encouraged in AA. It's even necessary. But as we all know through our own personal stories, change oftentimes is difficult—for an individual and a group as well. My circuitous route to bring about a point here is that the Shalom Group of AA in Jerusalem,

Israel, has moved locations. After 27 years at 24 Hapalmach Street, the building was sold. We're moving to a new room located in the center of the city, and it's going to be great ... as soon as we get over the sadness.

I guess to appreciate the weight of the issue, one has to understand AA in Israel. In Jerusalem, the Shalom Group is just about the only game in town. There are a couple of other meetings around, but for the last 27 years, it's been the center of AA in the whole country. AA in Israel isn't like it is in major cities in the U.S. or elsewhere. We don't have meeting books. We have a meeting sheet of paper that covers every major city in the country—on one side of the paper. At first glance, one might say we have a long way to go with AA in Israel, and we do. However, we've come a long way too.

I got sober in the Chicago area in 1988, and I moved to Jerusalem in 1996. At that time, the Shalom Group on Hapalmach Street had two English-speaking meetings a week: Mondays and Thursdays at 8:45 p.m. That was around 15 years ago. There were about eight to 10 regular attendees, and it was a nice group. Having eight years of sobriety at the time, I was already considered an old-timer (not in age) because that was how new AA was in Israel. I immediately took a very active role in the group and still do. The first thing on the agenda was to add more meetings.

It has been a slow process, and not without its requisite bumps in the road. But today, the Shalom Group boasts at least one meeting a day, and on many days there are two meetings. The group has grown, shriveled and grown again. People came to live in Jerusalem from other parts of the world and brought their sobriety with them or gained it at 24 Hapalmach Street. There are Hebrew meetings and Russian meetings as well, but the English-speaking group has always been the backbone.

Many of us came to the Shalom Group having gotten sober someplace else. But the greatest joy I've experienced over the past 15 years has been watching a new person enter that small room in Jerusalem, get sober and stay sober.

When I say it's a small room, I'm not exaggerating. If we get 30 people in that room, it's pretty much standing room only. We don't experience the mega-meetings that are commonplace in other AA groups around the world. But perhaps because of this, it makes our little group on Hapalmach Street that much more important. I've heard countless times over the years how, upon walking up the steps to the meeting room and entering the door, one feels a sense of safety. A sense of being home.

Being located in Jerusalem, we get a lot of tourists who visit our meetings. You can always spot them when they walk through the door. They're the ones who exhale loudly when they see a group of AAs sitting around the table smiling. Evidently, Israel can be an intense place to visit, and the Shalom Group has offered many a harried alcoholic traveler a chance to get centered again.


There are probably a lot of people reading this right now who have visited us on Hapalmach when you were in Jerusalem. No doubt, you've probably met me along the way. People always leave with great memories of our group and take stories back with them to their home groups. That won't change, because the group is still the group—only the address has changed.

It's difficult not to get nostalgic, though. That room truly was like an old friend and will be missed by us all. Twenty-seven years is a lot of time and that room has absorbed some outstanding sobriety, some tragic heartbreaks and some hilarious comedic moments. It deserves a tip of the hat.

I know that every time I'll drive by, I'll want to park my car and run up the stairs to see who is at the meeting. Old habits are hard to break. But all the memories will remain with me, and fond ones they are. It's time, though, to make new memories. We always do.



Why Be Organized?

A conversation with the coffee crew reminds this "elder statesman" why AA is set up the way it is

When we ran out of creamer at our meeting the other day, I heard, as I often have, a couple of members say, "AA ought never be organized!"

Right then, the elder statesman status I aspire toward started leaking red. "Do you know what Bill meant by the word organize?" I asked the members. I just wanted to be helpful so they could understand Tradition Nine. They probably don't even know where that quote comes from, I thought.

Fortunately, I was schooled to just share my experience, strength and hope. So I said, "I learned that when Bill wrote, 'A.A., as such, ought never be organized,' he meant that we do not have membership rules or a way to discipline our members. He wanted the members to run the show." They looked at me and politely said, "Uhhuh," and walked away, giving me a strange look.

So in my daily inventory that night, I looked back at my early memories of the Twelve Traditions. I too had gone through the same familiar stages of thinking huh? to who cares? when I was new. My sponsor suggested that I care, so I finally began studying the Traditions.

But I had to ask myself, how often do I listen nowadays when the Ninth Tradition is read in a meeting? Do I really listen to the words? Well, honestly, hardly ever, which is a shame, since I consider the Traditions to be critical for the Fellowship to survive.

Now comes the salient question: Do I understand Tradition Nine? The long form says: "Each AA group needs the least possible organization," and then goes on to describe the minimal organization that AA as a whole requires. Then, I go to my dictionary. (Yes, a book. I know I'm old, but Bill didn't have a cell phone.) It says of the word organize: "to form into a coherent unity or functioning whole" and "to arrange by systematic planning a united effort." Wow, that's a lot of AA

packed into one word. Perfect for Dr. Bob's admonition to keep it simple.

Bill, of course, knew that not every member could attend the General Service Conference or serve on the General Service Board, so a simple structure of electing delegates and trustees to attend was created. This structure allows communication between the AA members to the Conference and back, with the beautiful side benefits of creating a mechanism for local and area services. He even throws in the egalitarian concept of the spirit of rotation. Dang, that Bill could write!

But, ah-ha! It's here that I hear some bashing of the "politics" of AA. I try to suggest that my perception of politics is personalities over principles, rather than our Twelfth Tradition of the opposite. Who provides the meeting schedules, staffs the hotlines, coordinates the institutions work, informs the public and maintains our website, not to mention the many less-well-understood Twelfth Step activities? But then some might say, "What about all those elections with the fancy titles?" Yes, we have service boards and committees, but we try to be directly responsible to the Fellowship as a whole.

Time for more inventory, I tell myself. How well do I remain responsible to AA as a whole? Do I get defensive about our service structure? How well do I help keep politics out of service? How well do I know and communicate AA's Traditions, with their deep meaning? How well do I, as Bill W. writes in the January 1966 Grapevine, "reckon AA in two words ... humility and responsibility"?

Dr. Bob, in his final public address at the first International Convention in Cleveland, said: "Our Twelve Steps, when simmered down to last, resolve themselves into the words 'love' and 'service." As in all things AA, I too can make more progress.

- GSO answers mail and fulfils literature orders from the fellowship.
- The Corrections committee continues to answer hundreds of letters a month, providing information and encouragement to alcoholics behind bars.
- The Literature Committee remains committed to ongoing projects including translation, ASL, and studio recording of pamphlets and existing literature.
- The Public Information Desk has been responding to media inquiries on staying sober through social distancing and AA's use of virtual platforms to fulfill our primary purpose.
- Archives documents the experience of the fellowship during the pandemic, ensuring that our fellowship is able to draw from this experience in the future.

For a full overview of the ways G.S.O. is continuing to serve the fellowship and overcoming Pandemic-related obstacles, please review the most recent Summer 2020 issue of Box 459 (News and Notes from the General Service Office of AA, available at aa.org).

District 05 serves as a link in the chain and helps facilitate the work that takes place within our General Service structure. We use our meeting time to orient and prepare General Service Representatives and our District-elected service workers for tasks they are responsible for. This includes introductions, presentations, and experience facilitating group consciences on Agenda Topics and Area Motions (California Northern Coastal Area 06 and San Mateo County District 05 General Service continue to operate virtually). We support the work of Bridging the Gap, Public Information/Cooperation with the Professional Community, Archives, and more within San Mateo County, each entity with a distinct purpose in reaching the still-suffering alcoholic. We also host annual events featuring some of our service entities to generate awareness and participation.



A Canine Step Nine

Some amends can be made with a milk bone and a little scratch behind the ears

When I was in the grips of my alcoholism, my dog was as close as I unwittingly allowed God to get. I loved and trusted my pet a whole lot more than people, especially those who had my best interest at heart. In discovered retrospect, that I expectations quite of people were disproportionate to reality. Nevertheless, my dog would lie patiently by my side while I nursed yet another "justified" resentment wrapped in a hangover. And she would lie there all day, if necessary. Even some days in sobriety now, when I'm tempted to withdraw from the human race, my dog keeps me tethered to life. Thank God for my dog.

As I make another inventory at this fiveyear mark of my recovery, I reflect on the place my dogs have had in my life and the amends I owe them. Some may balk ... making amends to a dog? Well, hear me out.

During my active alcoholic years, I must acknowledge my dogs' inconsistent and unacceptable treatment by me: Staying out late, not coming home at all, irrational fits of yelling which left them running for cover, feeding them cheap food, forgetting to feed them at all, no real exercise, minimal play time, little attention, and intolerance for accidents on the carpet, which were really my fault.

With each selfish, irresponsible decision, I piled up more and more guilt and shame, which I doused with a drink. So, making amends to my pets makes perfect sense to this recovering alcoholic.

Today, I make my K-9 amends much like I make my living amends to my human family. I begin by asking my Higher Power to keep me sober each day and walking in the sunlight of the spirit. And every day, I do the one thing that God cannot do for me, and that is to surrender my will to something much bigger and better than me. I follow this up with lots of scratches behind the ears, milk bones and plenty of love and ball fetching. I never had any children. Like many alcoholics, my pets are my family. I look at the relationship between me and my dogs as a commitment—and a gift of grace from God.

A beautiful quality about dogs is one they share with God—forgiveness. One of life's highest pleasures is being enthusiastically greeted at the door by my devoted and trusting dog.
