What does our Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

- Maintain a 24/7 telephone line which responds to inquiries from still-suffering alcoholics seeking help, A.A. members in need of information, and from members of the professional community and the general public. After office hours, this line is staffed by Teleservice volunteers.
- Maintain a Twelfth Step volunteer list.
- Maintain and publish group meeting schedules, in print, on our website, and in the Meeting Guide App.
- We stock a large selection books and pamphlets for sale (many are available in Spanish).
- ❖ We offer sobriety chips for sale, for both individuals and groups.
- We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, as well as with San Mateo County General Service District 5 and the Northern California Council of **Alcoholics Anonymous**
- We support and participate in many local A.A. events such as Unity Day and the holiday Alkathons.
- We maintain our web site, aa-san-mateo.org, with up-
- to-date meeting listings, a schedule of A.A. events, the High Sobriety newsletter, and links to other A.A. web sites,
- We maintain a library of A.A. speaker CDs which are available for rent for a nominal fee.
- We publish the newsletter, High Sobriety, sent at no charge to all registered San Mateo County A.A. groups and available by subscription to all A.A. members. Faithful Fivers receive a free copy as well.

Who pays for our Central Office? We, the members of A.A., do. Our Seventh Tradition states that we are self-supporting through our own contributions. Central Office also receives donations from individual alcoholics (such as through our Faithful Fivers program). Other sources include our annual anniversary party and income from the sale of A.A. literature.

I Found God on Madison Avenue

After years of searching, his moment came, somewhere around 58th Street

I have spent most of my life trying to fill that empty spiritual space that takes up so much room inside of me. It became a quest.

As a child of the 60s, I rejected organized religion, the cause of most of the world's problems and wars. I was certain spiritual enlightenment lay elsewhere. I looked for it sitting around campus smoking grass and expressing my artistic vision at the potter's wheel. I made a lot of ashtrays.

By 1970 I was married with a child and had survived a stint in the army. I started a business, had another child and was living the American dream. But I still had this emptiness inside. Doing business in those days centered around heavy drinking. And I intended to succeed. I progressed from surreptitiously dumping my drinks into potted plants to becoming the life of happy hour.

Still searching myself and hoping to spare my children the pain of that "empty space," my family joined the Unitarian Church. It was a safe, noncommittal choice: no prayer, no God, no Jesus. This was agreeable until shady collection plate matters proved once more that organized religion was a farce. And anyway, I was happy to celebrate the birth of Jesus if I could do it with sidecars, daiquiris, rum punches and my new favorite—brandy manhattans.

Then I discovered self-help books. I locked onto one about alternate realities and mind-altering plants. My spirit animal would show me the way to spirituality. I procured a guide to take me into the Arizona desert to perform the peyote ceremony. After throwing up for two hours, I had a vision—of a grasshopper. This was not satisfactory. I wanted to be a falcon, a jaguar, an eagle—something to reflect my inflated ego. My guide said I could be a crow. Over a quart of bourbon I manipulated him into agreeing I was a raven. It sounded much more regal. Needless to

say, my trumped up spirit animal guide led me nowhere.

But then all the "New Age" gurus of the early 80s entered the fray, and I was a believer. I arranged the prescribed crystals under my mattress, I attempted astral projection, I went to a sweat lodge in the mountains of New Mexico. I attended a seven-day retreat of meditation, discovering my inner child, and "hooking up" to share this newfound spiritual connection. The primary spirit was vodka. The highlight of the week was a firewalk. We all committed to getting drunk and high before facing the redhot coals. Afterward we exclaimed it was inspiring. It was a miracle we didn't burn our feet! Later that night the local convenience store had a run on burn cream and aloe gel. Today my crystals rattle around in a box my grandchildren play with.

Obviously I was trying too hard. My spirit needed relaxation and recreation. I learned to scuba dive and became a fixture in Puerto Vallarta. These trips were one part diving, nine parts drinking. In a small village in the mountains, a shaman assured me that he had the vehicle to guide me into the spirit world. I was introduced to raicilla, a type of moonshine tequila. The brewer/shaman added special herbs that the "ancients" used to gain a close connection to mother earth and find true peace. I drank the spirit, my head began to spin and I became completely paralyzed. I don't know how I got back to my hotel room, but the visions I saw were anything but peaceful.

My children grew up, my marriage ended and I continued my search—with spirits in a bottle. I drank when I was troubled, I drank when I was celebrating. Every day became a failure or a success, and I drank. Ultimately vintage, age, origin didn't matter. I bought what was on sale at discount liquor stores. I came into AA on May 23, 2007, and I have never picked up another drink.

I went to meetings, did the Steps, and worked with a sponsor, but I still had a spiritual void. Life was measurably better, but where was my "God shot" that everyone else seemed to get with sobriety? In December 2009 I was living in New York and was diagnosed with aggressive stage III cancer. My only option was surgery. If they failed to remove all of the cancer, my chances were slim. I was told to get my things in order. I railed that this was unfair. Had I not gotten sober, changed my ways? Why was I being punished?

Ten days after my surgery I was walking up Madison Avenue toward the surgeon's office to hear whether I would live or die. The night before I had desperately tried to contact God. "Please let me live," I said. "Don't do this to my children. Don't put me through a painful death." These were my prayers—they were all about me and they were hollow.

But something happened on Madison Avenue right around 58th Street. I didn't hear a voice. The light around me didn't change. But a message came to me: "Everything will be fine." And suddenly it didn't matter what the doctor said. I knew I was going to be alright no matter the diagnosis. My Higher Power, whom I choose to call God, entered my life that day and has been with me every day since. That moment of enlightenment gave me the ability to reflect back on my Step work and view it in a different light. I no longer look for an herb, a rock or a bottle for my spiritual fulfillment. It is always right here with me. I am eternally grateful. My cancer gave me a gift and my sobriety prepared me to understand that gift when it was presented.

A.A. Around the World

On the Shores of the Aegean

A beacon of hope is lit in Turkey

MERHABA! I sobered up in 1990, and my first home group was Izmir's Stories of Sobriety (SOS) Group in Turkey which consisted of Americans associated with the military. The only Turkish person was my sponsor's wife. Meetings were held in the base chapel and in members' apartments around the city of Izmir, with attendance from two to maybe 10 people. Early in my program my wife brought a Turkish newspaper article to my attention that described the hopeless nature of alcoholism amongst Turkish people. The article described carnage caused by alcoholics. The article also described that drying out drunks only to have them return to drinking again and again was not working and clearly demonstrated the hopeless nature of drunks. The writer and professionals interviewed were obviously not aware of AA. I brought the article to a meeting and asked what we could do to carry the message to the Turkish people crying for help. I had less than a year of sobriety and someone with several years of sobriety lectured me about attraction rather than promotion.

This was my first lesson on what happens when you place people in the program too high on a pedestal. This also taught me a bit of acceptance and tolerance of others. I strongly believe that at the time, I was not ready to pass on something I did not yet have; I had just scratched the surface of my Fourth Step. After the first Gulf War, our group was asked to leave the chapel for security reasons and our seven meetings a week began musical meeting places from the Air Force Clinic to the Turkish--American Association to my sponsor's apartment and so on.

Work on translating the Big Book had started shortly before I sobered up by some hard working folks in Izmir, Istanbul and Ankara. After a year and a half of sobriety, I had cleaned house, was working through the Steps and had just begun the early practice of our daily maintenance Steps, Steps Ten and Eleven. Public Information placed ads in national papers and magazines, and reaction was the same as to the early Saturday Evening Post article. It was then, I believe, that my Higher Power said I was ready and that my house was in just enough order that I finally had something to give. Our group began hopping from one Twelfth Step call to the next, with little success for our new prospects. However, it did keep us sober.

We were handicapped in our work; our biggest problem was that most of the folks were unable to read English and the only Big Books available were in English. It truly helps to have a Big Book or some other AA literature that can be given to a new prospect to read over. I learned early on that all the answers are in the Big Book. I know I wouldn't have lasted long if I couldn't read and understand our basic text.

THE Big Book was translated into Turkish with a lot of elbow grease from AA members in Turkey and AA World Services and we were provided a substantial amount of copies of the Turkish Big Books for free to facilitate our Twelfth Step efforts.

The ads in the Turkish media got the attention of a psychiatrist at Ege University Hospital in Izmir, Turkey. This doctor, like Dr. Silkworth, believed there was more to the recovery of alcoholics than just drying them out and releasing them. Our group met with this doctor and began immediate cooperation that caused an explosion of newcomers, over 50 Turkish people in a matter of a few months. One of the contributing parts of our success was the Turkish Big Book and "Twelve and Twelve". I was also given the gift and privilege of sponsorship of over half a dozen individuals. I was able to share the program with my new sponsees and in turn they taught me Turkish. My sponsor always told me about how much he learned from his sponsees. The love and wonders of the program that I shared with them was returned tenfold. As our little group was growing, I, too, was growing in the program. I had been through the Steps, but class was still in session.

I also was able to see first-hand what happens when pieces of the program are put together: Our

group twelfth-stepped a young lady by sharing our experience, strength, hope and how we stay sober using the AA program. She couldn't read or speak English, and the AA books we had at the time were all in English. She left and returned to us a year later, this time badly beaten by booze. We twelfth-stepped her again and gave her a copy of the new Turkish Big Book. She took to the program like a drowning victim to a life preserver. I had the pleasure to be one of her sponsors. When I left Turkey in 1995 she had worked the Twelve Steps, she had two years of sobriety, and she had begun to sponsor others.


WITH the help of God, GSO's contribution of books, a Turkish psychiatrist and Twelfth Step efforts of members across Turkey, our tiny group rose to over 50 in a few months. Several of the group's older members and me had always dreamed of getting the SOS Group a meeting place. This dream came true with the grand opening of the group's own meeting place, a penthouse apartment with two meeting rooms, bathrooms and a kitchen. I believe this happened just as God wanted it to. My wife used to complain, like Lois did, that she was frustrated from cleaning up after a bunch of drunks and wondered when our apartment would become our home once again. The group was no longer dependent on Americans to keep it alive.

In 1995 I was transferred from Izmir Air Station, Turkey to Mountain Home AFB in Idaho, from a city of over 3,000,000 on the Aegean coast to a landlocked town of 8,000--what a culture shock! In 2000, I returned to Izmir for a visit to find the young lady and many other I sponsored still sober and sponsoring others. This story still warms my heart today and brings me tears of joy when I share it with others.

The SOS Group was still meeting in that penthouse apartment. Today the Izmir Group is fully self-supporting and still meets in the same place with an AA meeting every day at 7 P.M., just as it did 14 years ago. The beacon of light set up by me, my wife, my sponsor, his wife and a few other Turkish AA members is still near the shore on the Aegean Sea, for those still-suffering alcoholics in need of help.




