What does our Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

- Maintain a 24/7 telephone line which responds to inquiries from still-suffering alcoholics seeking help, A.A. members in need of information, and from members of the professional community and the general public. After office hours, this line is staffed by Teleservice volunteers.
- Maintain a Twelfth Step volunteer list.
- Maintain and publish group meeting schedules, in print, on our website, and in the Meeting Guide App.
- We stock a large selection books and pamphlets for sale (many are available in Spanish).
- ❖ We offer sobriety chips for sale, for both individuals and groups.
- We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, as well as with San Mateo County General Service District 5 and the Northern California Council of Alcoholics Anonymous
- ❖ We support and participate in many local A.A. events such as Unity Day and the holiday Alkathons.
- We maintain our web site, aa-san-mateo.org, with up-
- to-date meeting listings, a schedule of A.A. events, the High Sobriety newsletter, and links to other A.A. web sites,
- We maintain a library of A.A. speaker CDs which are available for rent for a nominal fee.
- We publish the newsletter, High Sobriety, sent at no charge to all registered San Mateo County A.A. groups and available by subscription to all A.A. members. Faithful Fivers receive a free copy as well.

Who pays for our Central Office? We, the members of A.A., do. Our Seventh Tradition states that we are self-supporting through our own contributions. Central Office also receives donations from individual alcoholics (such as through our Faithful Fivers program). Other sources include our annual anniversary party and income from the sale of A.A. literature.

Central Office has resumed regular hours Monday through Friday from 8:30 am to 4:30 pm.

More Than Words Could Say

For one AA, Step Eight is all about connecting

STEP EIGHT: Made a list of all persons we had harmed, and became willing to make amends to them all."

There's an urge within many of us to say something, to let it fly without a thought. At least there is for me. Yet many times, the strongest response I can give is silence. I never saw this concept so honestly and eloquently exhibited as I did at a recent study group meeting on the Eighth Step.

After reading the "Twelve and Twelve's" rendition of Step Eight, the discussion started weaving around the tables involving laments such as, "I haven't gotten that far yet," and "My sponsor told me not to forget to put myself on the list as a person I had harmed." Then we came to Dan.

Dan is a war veteran. He came back home from his war, married, demolished his family with his drinking, then one night demolished himself in a head-on collision with a light pole. It left him disabled, with a brain stem injury. When I first met Dan he tested my tolerance as I tried to follow his train of thought. The more I made an effort to do it, the more I learned to love and learn from him. Like most of us, he could go on and on or be done in a minute, but there was always a golden nugget I could pan from his comments. I always waited anxiously for Dan's turn.

"My name is Dan," he said, "and I'm an alcoholic." Then he sat there in total silence. It was extremely unsettling. Dan's head bobbed as if he was reverently acknowledging each of his precious amends made with every nod of his head. There was just silence as the group looked on in awe.

I saw Dan's eyes glaze as I envisioned him feeling the sting of transgressions that prompted his amends. He graced us by showing in silent beauty what it is like to be humbly human. There was not one tear. Remorse was not part of this silence's vocabulary.

Dan had accepted what he'd done, made his amends and gone on as best he could.

Then, head still bobbing, Dan looked at each of us one by one. It was a serious, but understanding, glance. At first I winced, but the meaning of his expression came to me: "We're all in this together or we are not in it at all."

Isn't that the basic truth of the Eight Step? Never in my life had I felt more a part of somebody or that somebody was a part of me as when Dan's eye fixed on mine. In his own way, Dan had told me it is not so hard to make our amends when we understand that, other than being alcoholic, we aren't so different from anyone else, nor they from us. For all of us on both sides of the fence, it is as simple as doing the right thing.

I don't know how much time passed at the end of this. "I pass," Dan said, as he interlocked his fingers and bowed his head. I looked around a stunned room. Dan had made more sense by saying nothing than many of us had with all our words. For me, it was a precious point of silence I will never forget.

A.A. Around the World

One Night in London

After 50 years, she's curious to find the man who kept the doors open so she could find us

On the 5th of August, 1968, at about 7:00 in the evening, I was walking up and down Holborn Kingsway in London. I was of two minds as to whether or not I would enter a certain building.

I had phoned AA a few days earlier with pretty much the same trepidation. I had planned to go to a meeting in Redcliffe Gardens, but I had lost my nerve and had gone into a phone box at the end of the road instead. Over the phone, I was given, among other addresses, the venue for the Young People's Meeting. I was warned that this group might be about to fold and that it was perhaps not the best one to go to, but with my intense fear of people—of everything—I preferred this option to those meetings that guaranteed good attendance.

The meeting was held in an old Methodist Hall. When I managed to get myself into the building and up some stairs to the first floor, I knew I had found the meeting by the AA books that were set up on the table. I still get that wave of relief when I arrive at an AA meeting with a display table of literature. There was only one man in the room and apparently (I learned later) he had been sitting there on his own for the past three weeks.

He welcomed me right away, and I said, "I don't think I am an alcoholic." "Are you worried about your drinking?" he asked. "Yes," I replied. "Then you are in the right place," he said.

And he was right. I now believe that brief exchange with that man was the most important one of my life.

As a Twelfth Step, I must have been rather hard work. I had lost all ability to converse with anyone and I was rigid with fear most of the time. At that first meeting, another man arrived (not a "young AA," which in those days was under 35), named Paddy and they took me to a coffee bar where I met a few other members. They could see I was young (18) and kept saying, "You'll have to meet Kathy." Kathy was actually 24, which at the time was an age I doubted I would reach. It seemed very old to me. I did eventually meet Kathy and a lot of fantastic people in those early London meetings.

A couple of years ago I came back to see the site of this important event in my life and found that Methodist Hall which had housed the meeting had become part of a hotel. Next year on August 5th I hope to stay for one night in the hotel in celebration of 50 years of being part of AA. I will have to wait another two years for my 50 years of sobriety birthday, but that meeting in Holborn Kingsway was the start.

The reason I am sending my story to Grapevine is that for many many years I've longed to be able to tell that nice man who sat there for three weeks on his own that his service and warm welcome led me to this happy, fulfilled life I have had. His name was Bob. His surname began with the letter "H" and he had an American accent. I presumed he might be Canadian. After that first meeting, Bob H. gave me his London telephone number and when I returned to London a month later to start a new job and a new life, he met me and took me to a weekend of AA meetings in the Crypt, Trafalgar Square, and I believe one at St. Patrick's and one in a basement off Oxford Street.

Bob looked a bit like Henry Fonda. Maybe it would be more accurate to say that once I was free of alcohol and could enjoy normal things like going to the cinema, I saw Henry Fonda in a film and he reminded me of Bob. If still alive, Bob would now probably be in his mid-80s. If anyone knows anything, or thinks they know anything of this man, please let Grapevine know.


My chief reason for writing my story is to show appreciation for every AA member who does such service, whether it's answering the phone, setting up a meeting or, like Bob, giving their time to keep a meeting running to ensure that the hand of AA is there for the next person who needs help.

I have spent all my sober life in Jersey, Channel Islands, where there are AA meetings every day of the week. And they're all held for the likes of me—an 18-year-old, now 67, who would not have reached 21 if not for members like Bob.

Virtual Newcomer

In March of 2020, when everything shut down because of COVID-19, I was terrified that the liquor stores would close. How would I get through a pandemic without alcohol? So I ran to stock up.

The next 10 days I drank nonstop, depleting all the boxes of wine I had purchased, and was quickly going through the vodka. I was a mess.

My husband, who loves me so very much, called my two sisters, both of whom are sober in AA. They came to my home and asked if I was ready to stop drinking. To me they were like angels coming from heaven! I was so ready. It was like the weight of the world had been lifted off me.

My very first AA meeting was a virtual beginners' meeting called the Easy Does It AA Group. It was so difficult for me to share and admit to being an alcoholic. But everyone welcomed me and encouraged me to keep coming back, which I did! I had no idea that all these virtual AA meetings were in their infancy. To me it was all I ever knew. I will forever be grateful for the Easy Does It Group.

I recently shared at one of my virtual meetings that getting sober didn't change my life, it changed the way I live my life. I am happier now than ever before. I am no longer dreading the day or just trying to get through it. I wake up every morning with gratitude and a clear head. AA helps me get ready to take on the day, good or bad—but sober!

I don't know what would have become of me if not for these online AA meetings. I want to thank the members who had the foresight and did the hard work to institute these virtual meetings when the pandemic hit, so people like me had the opportunity to get sober.
