
58th Annual Women's Conference

What does our Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

- Maintain a 24/7 telephone line which responds to inquiries from stillsuffering alcoholics seeking help, A.A. members in need of information, and from members of the professional community and the general public. After office hours, this line is staffed by Teleservice volunteers.
- Maintain a Twelfth Step volunteer list.
- Maintain and publish group meeting schedules, in print, on our website, and in the Meeting Guide App.
- We stock a large selection books and pamphlets for sale (many are available in Spanish).
- We offer sobriety chips for sale, for both individuals and groups.
- We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, as well as with San Mateo County General Service District 5 and the Northern California Council of Alcoholics Anonymous
- We support and participate in many local A.A. events such as Unity Day and the holiday Alkathons.
- ❖ We maintain our web site, aa-san-mateo.org, with up-
- to-date meeting listings, a schedule of A.A. events, the *High Sobriety* newsletter, and links to other A.A. web sites,
- We maintain a library of A.A. speaker CDs which are available for rent for a nominal fee.
- We publish the newsletter, High Sobriety, sent at no charge to all registered San Mateo County A.A. groups and available by subscription to all A.A. members. Faithful Fivers receive a free copy as well.

Who pays for our Central Office? We, the members of A.A., do. Our Seventh Tradition states that we are self-supporting through our own contributions. Central Office also receives donations from individual alcoholics (such as through our Faithful Fivers program). Other sources include our annual anniversary party and income from the sale of A.A. literature.

Central Office has resumed regular hours Monday through Friday from 8:30 am to 4:30 pm.

High Sobriety 5 February 2022

STEP TWO: Came to believe that a power greater than ourselves could restore us to sanity.



SIMPLE RULES

During my 44 years in sobriety, I have heard a lot of AA sayings and I've heard them many times. I know a great many people who get a lot of relief from these sayings but I must admit that one means more to me than all the others: "We came. We came to. We came to believe."

I went to my first meeting because I was trying to get my brother to sober up. It seems he got a bit too drunk and left our mother at Disney World. Because she was worried about him, I told her I'd get him to an AA meeting. Where I got that idea, I'll never know. I'd heard of AA but I had never been to a meeting.

He agreed to go, but said wouldn't go with me until he had a chance to "check it out" first. So I went to the next week's meeting (We came). When I saw the poster of the Twelve Steps on the wall, it struck me hard. It looked like the answer to all the strange problems of my life. I wasn't crazy, I was an alcoholic (We came to). This was the place where I could be "restored to sanity."

I married at a young age to a very good man, but alcohol had already become my true loved one. I left my husband and children many times to go out drinking, coming home at all hours. Over time, I was convinced that my husband was my problem. He was the reason I drank and couldn't get my life under control. I ultimately left him and spent many years looking for a geographic cure and getting "saved" in one church after another. I spent my fair share of time in asylums too, but nothing seemed to help. But when I saw those Twelve Steps that day, a light turned on in my head.

The next day, standing by the road at a pay phone with my two small girls, I called the AA hotline. I asked if they could put me in touch with someone who could help me gain an understanding of the program and my problem. To my great good fortune, a woman named Mary called me back and agreed to take me to a meeting.

For the next 38 years, Mary walked me through AA and coached me through life. One of the first things we talked about was a need for me to come to grips with some sort of Higher Power. I had no use for God when Mary and I met. He was to blame, in my mind, for causing my father's death at a relatively young age and for causing my brother to contract polio when he was still a teenager. I couldn't even stand to hear the word God. But Mary taught me many things, including her belief that God acts in this world through other people. I kept going to meetings and I talked to Mary every day. I had a hard time understanding what "God's will" was for me. Mary explained that God doesn't care which hamburger place you eat at. He just wants you to eat and stay healthy.

With a lot of help, I arrived at my "We came to believe" moment. I came to believe in a God of my understanding and I came to believe in the power of sponsorship. I have sponsored dozens of women over the years. Some have slept on my couch until they got on their feet. Some came and some are gone. My rules are simple: Get a Big Book and read it, go to meetings and call me every day. Be where you are supposed to be when you are supposed to be there. And I do not deal with two things: romance and finance.

Now I'm 88 years old and I try to get to at least one meeting a day. I speak when I'm asked to and I talk to a lot of men and women before and after my meetings. Some tell me they learn from me and I know that I learn from each and every one of them. The craziness of my life is gone, except that it serves to remind me of what life was like before "I came, came to and came to believe."

TRADITION TWO: For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

A WORD IN EDGEWISE

The "informed group conscience" is a topic that I love to talk about. I believe it is one of the most important things we strive for as a Fellowship.

Tradition One reminds us that personal recovery depends upon AA unity. The informed group conscience is one of the main building blocks of that unity. Tradition Two states that our single, ultimate authority is a loving God as he may express himself in our group conscience. So, the group conscience is how God has a voice in our decisions. In other words, if there is no group conscience, God can't get a word in edgewise.

The group conscience is the collective conscience of all the group members. An informed group conscience requires that all information be shared before a vote is taken. It requires that we listen to minority opinions with an open mind and that we treat all members of the group as equals. It requires us to practice all of AA's principles in our interactions with other group members and to use caution when dealing with dominant opinions. It requires a willingness to work with patience and tolerance for each other, sometimes discussing things many times before a final decision is made. Many of us have exclaimed, what an order!

It is important for long-timers to realize that their opinions might carry more weight than the opinions of other group members. It is important to allow the group to work through items without exerting too much influence. Perhaps it is best that long-timers keep silent while the group speaks its mind and offer thoughts only after others have had their say. This can help guard against other members playing follow-the-leader.

Probably the greatest enemy of the informed group conscience is prematurely calling the question. This is the one problem that I have seen the most and I think it is the most destructive of all. This practice stops the discussion and if a majority of members have decided they have heard enough to make a decision, it takes the measure directly to a vote. This is a ripe environment for a group to make a huge mistake. You might be thinking, That is why we have minority opinion. And you would be correct, that is why we have minority opinion is not the same as allowing open discussion because minority opinion is, by definition, one-sided.

The real problem with all of the things that damage the ability of a group to reach an informed group conscience is that individual members are left feeling marginalized and unheard. When the discussion is not allowed to completely unfold, allowing all members to be heard, there can be disagreement that remains long after the vote. This unspoken dissension can, and often does, lead to divisiveness and taking sides, which can put our group in danger.

Personal recovery does, after all, depend upon AA unity. And our one ultimate authority is God, presuming he can get a word in edgewise.

The informed group conscience is about more than a count of "yes" and "no" votes. It is the spiritual expression of the collective group. It takes great care to arrive at that expression in a way that respects each individual, as well as the autonomy of the group. Practicing all of our principles in all of our affairs to the best of our ability is the only path.

Valentine's Day in the Detox

I'm coming up on a year now and I will tell you, it has been fun. I've heard a lot of people on annual birthday nights say, "This has been a real hard year for me!" And maybe it has, but for me it has been a wonderful journey.

On February 9, 2008 around 5:30 in the afternoon, I was arrested outside my home in front of my family and all the people on my street. I remember very little about that day. I do remember that I was very drunk, very angry, and very mean—I wish I could forget the whole damn day but I cannot. A lady once told me that, "If you can't remember your last drunk, you probably haven't had it yet." Makes sense to me. The more time that I get, I start to remember the day more and more. I have even had dreams of it, but things are still a little foggy at times

Getting out of jail the following morning, things became very clear to me. I thought to myself, "You have really done it this time." No one was there to get me and no one would answer the phone calls. As the day progressed, I finally got hold of my boss at my job. He too was fed up, and as we talked he kept hinting about the fact that I needed help and if I didn't get any help, that my time with the company was over too. I had been to treatment two times before. This would be the third time in five years that I would have to go through this again. How could I honestly think that this time was to be any different? I really was hopeless. I went through detox and treatment in West Texas before and it didn't work. But I didn't give it any effort either. I wanted people to hand me the gift of sobriety. One of my character defects to this day is being lazy. It is something that I really have to work on on a daily basis. I do a pretty good job at it, but it is tough at times.


While in treatment I was hit with divorce papers—on February 14th to be exact. What a way to spend Valentine's Day: in detox signing divorce papers. There was also a restraining order and I was not allowed to be around my two-year-old son. That was tough to swallow. I love my son very much, but I used to love to drink more. Bill W. once wrote, "Alcohol was my master." I know what he was talking about, but today it is not!

After treatment, I went to a halfway house for men with drinking and drug problems, and that is where I learned who I was. I finally found myself, and honestly I really didn't like what I found. This is where I learned that alcohol and drugs weren't the problem, I was. Finally, I started to understand what you folks were talking about.

One of the many things you learn in AA is who we really are, what we like and what we really don't like. And, I really didn't care for myself in any way. So here is where I changed, or should I say tried to start making some changes. I finally turned it over to God—I can't run the show anymore. I got a sponsor, an old timer with a lot of time. The sponsor that I use today is one I had before in 2005. He is the perfect fit for me. If you saw us together you would think we were two fellows that would not normally mix. I think I've read somewhere and I believe that God puts certain people in our lives for a reason. He is one of those people. I feel very lucky to have him as a sponsor and a friend. He would be the first one to tell you though that he is just doing what you people taught him—so, thank you! Thank you for giving me hope! Thank you for always leaving the doors open! Those promises that I have heard about are indeed coming true!
