

# **GENERAL SERVICE NEWS**

Fifth Edition of the Big Book of Alcoholics Anonymous Deadline: October 31, 2022

The Preface to the Second Edition of the Big Book explains that revisions to the personal history section of the book were made in order "to represent the current membership of Alcoholics Anonymous more accurately, and thereby to reach more alcoholics." In that spirit, the 2021 General Service Conference recommended that: "a Fifth Edition of the Big Book, Alcoholics Anonymous, be developed, including an update of stories to better reflect the current membership, keeping in mind the 1995 Advisory Action: "The first 164 pages of the Big Book, Alcoholics Anonymous, the Preface, the Forewords, 'The Doctor's Opinion', 'Dr. Bob's Nightmare', and the Appendices remain as is." In response to this Advisory Action, the trustees' Literature Committee is seeking a wide range of A.A. recovery experience of members in the Fellowship. Recognizing that all stories are of value, the Literature Committee is searching for recovery stories that are from a broad cross-section of our local communities. As Bill writes on page 29 of the book Alcoholics Anonymous: "Our hope is that many alcoholic men and women, desperately in need, will see these pages, and we believe that it is only by fully disclosing ourselves and our problems that they will be persuaded to say, 'Yes, I am one of them too; I must have this thing." It is the Literature Committee's shared hope that any new stories from our current membership will help future alcoholics to identify and find recovery in the pages of a Fifth Edition. 

## What does our Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

- Maintain a 24/7 telephone line which responds to inquiries from still-suffering alcoholics seeking help, A.A. members in need of information, and from members of the professional community and the general public. After office hours, this line is staffed by Teleservice volunteers.
- Maintain a Twelfth Step volunteer list.
- Maintain and publish group meeting schedules, in print, on our website, and in the Meeting Guide App.
- We stock a large selection books and pamphlets for sale (many are available in Spanish).
- We offer sobriety chips for sale, for both individuals and groups.
- We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, as well as with San Mateo County General Service District 5 and the Northern California Council of Alcoholics Anonymous
- We support and participate in many local A.A. events such as Unity Day and the holiday Alkathons.
- ❖ We maintain our web site, aa-san-mateo.org, with up-
- to-date meeting listings, a schedule of A.A. events, the *High Sobriety* newsletter, and links to other A.A. web sites,
- We maintain a library of A.A. speaker CDs which are available for rent for a nominal fee.
- We publish the newsletter, High Sobriety, sent at no charge to all registered San Mateo County A.A. groups and available by subscription to all A.A. members. Faithful Fivers receive a free copy as well.

Who pays for our Central Office? We, the members of A.A., do. Our Seventh Tradition states that we are self-supporting through our own contributions. Central Office also receives donations from individual alcoholics (such as through our Faithful Fivers program). Other sources include our annual anniversary party and income from the sale of A.A. literature.

Central Office has resumed regular hours Monday through Friday from 8:30 am to 4:30 pm.

STEP FIVE: Admitted to God, to ourselves, and to another human being the exact nature of our wrongs



**SHARING EVERYTHING** 

Who knew he'd have a spiritual experience telling his secrets one morning to a man he barely knew?

I was not spiritual growing up; the concept of God was nonexistent for me. My parents grew up in very different religious traditions. They raised me in a nonreligious but spiritually open-minded way of life.

In my mind, I was certain that there was no God because when I saw people with mental and physical disabilities, I thought such conditions were too unfair for there to be a God.

When I came to AA I was offended by the spiritual aspect of the program. I just wanted to get sober! The beginning of my spirituality, I believe, started when I heard these hard-to-believe inspirational stories from the staff of my rehab. That's when I realized I was meant to be there. But who, I wanted to know, meant for me to be there?

After moving to California to enter sober living, I quickly acquired a sponsor and started the Steps because, when sober, I discovered that I am quite good at following directions. Even so, I didn't truly believe in a Higher Power until I did my Fifth Step and shared my life story with my sponsor.

The spiritual experience I had that day is something I will never forget. By that time I had been praying for a couple of weeks, even though I was not fond of it. Then, on the morning of the day I did my Fifth Step, I got the idea of praying for my Higher Power to give me signs of his existence.

My sponsor picked me up around noon and we went to a local park where people were walking their dogs. On this beautiful day in southern California, we sat down on a sunbleached wooden bench. Over the next few hours,

I shared my fearless moral inventory with this man I didn't know all that well. I didn't then understand the nature of the Steps' promises. I was really surprised that I would feel magically relieved and forgiving afterward.

When we were done, my sponsor told me that I should go and meditate for one hour so I could reflect on the work I had done so far and to see whether there was anything more I needed to add. After my sponsor dropped me off at home, I rode my bike back to the same park for my meditation. When I arrived, I saw another sponsor and sponsee doing Step work while sitting on the very same sun-bleached bench that my sponsor and I had sat on earlier. They must have arrived minutes after we had left.

As I meditated on the day's events, I realized that something out there heard me pray that morning. I began to feel at peace with myself and my sobriety and felt a satisfying feeling, like finishing a nice Thanksgiving dinner with family. I was now convinced my Higher Power was watching out for me. It still is to this day.

This spiritual experience taught me that I'm never alone on my path in sobriety. Spiritual change is inevitable; accepting it is the best thing I can do.

# TRADITION FIVE: For Charlie's Sake

Over coffee at an all-night cafeteria some years ago, disagreements flared among four or five tables of AAs. There was dissension about the bookkeeping of the clubhouse treasurer, about dues and rules for membership, about the brand of coffee, and about the right of the program secretary to schedule a nonalcoholic speaker. I recall feeling vehement about several of these matters, and I expect I got loud, too.

Suddenly, someone brought to our attention a newcomer who had attended his very first meeting that night. All arguing ceased, as if by magic. Everyone pitched in to comfort Charlie and encourage him. Even those of us who did not care for each other acted polite and friendly, for new Charlie's sake.

We ended the evening amicable and united. Although this happened in 1945, before our Twelve Traditions were written, their good sense prevailed among us. It was a beautiful demonstration that "Each group has but one primary purpose—to carry its message to the alcoholic who still suffers," our Fifth Tradition. No one doubted that Charlie's welfare was more important than our petty arguments.

For me, there was still another lesson embedded in that one. Since I was so new myself, I had been made to feel very much like the most important alcoholic present—until then. But when Charlie appeared, I wasn't. Much later, I realized that my nose had not gone fiercely out of joint, that I had not gone all-over jealous. I had been so eager to help Charlie (with my vast store of AA knowledge gained in about six weeks) that I had not suffered even a twinge of sibling rivalry. I began to think of someone else, not of what I wanted.

It was a classic illustration of the "twelfth suggestion" made in the book Alcoholics Anonymous at the beginning of Chapter 7: "Practical experience shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics. It works when other activities fail."

So the Fifth Tradition, like the Twelfth Step, encourages me to become progressively less self-concerned and more concerned about others. Traditions repeatedly have that effect on me, and that is why I rank them as highly significant in our process of recovery.

The Fifth, like others, has a liberating effect. As AAs, we don't have to get tied up in owning real estate or operating clubs, with all the organizational, legal and financial hassles and ego battles such projects would involve us in. We need not try to become a medical or a religious fraternity, an educational organization or a political one.

Because of the Fifth Tradition, we are free of the necessity of raising large sums, or trying to change society. It is not our purpose as AAs to educate children about drinking, nor to teach the medical profession or the government about alcoholism. These might be side effects or spin-offs of what we do, just as a network of enjoyable and therapeutic social activities may also result from AA life. But they are not our chief purpose; they are subordinate to our goal of staying sober and helping others.

If there is any one thing on which all, or nearly all, AAs can agree, maybe our primary purpose is it. There's a world of things we can all disagree on. We do not have to see eye-to-eye on theological issues, on politics, on the causes and psychology of alcoholism, or even on how to stay sober. So it is beautiful, I think, for us to have one notion we all salute and honor--our primary purpose. When we carry the message to the alcoholic who still suffers, it binds us together and can heal ever so many wounds.

  - The Trustees' Committee on Cooperation with the Professional Community/Treatment and Accessibilities is initiating the production of more interviews from members of the U.S and Canadian Armed Forces. The goal of this

- effort is to improve A.A.'s outreach and identification with members of the U.S. and Canadian military. A major part of this work will be the production of several audio/video products where individual A.A. members who are currently serving or recently retired will share their experience with particular emphasis on recovery in A.A. while serving in the military.
