What does our Central Office do?

The San Mateo County Fellowship's Central Office belongs to the A.A. groups of San Mateo County. We help carry A.A.'s message in the following ways (and more):

- Maintain a 24/7 telephone line which responds to inquiries from still-suffering alcoholics seeking help, A.A. members in need of information, and from members of the professional community and the general public. After office hours, this line is staffed by Teleservice volunteers.
- Maintain a Twelfth Step volunteer list.
- Maintain and publish group meeting schedules, in print, on our website, and in the Meeting Guide App.
- We stock a large selection books and pamphlets for sale (many are available in Spanish).
- We offer sobriety chips for sale, for both individuals and groups.
- We work closely with local A.A. service committees: Bridging the Gap, Hospitals and Institutions, Public Information/Cooperation with the Professional Community, as well as with San Mateo County General Service District 5 and the Northern California Council of Alcoholics Anonymous
- We support and participate in many local A.A. events such as Unity Day and the holiday Alkathons.
- We maintain our web site, aa-san-mateo.org, with up-
- to-date meeting listings, a schedule of A.A. events, the High Sobriety newsletter, and links to other A.A. web sites,
- We maintain a library of A.A. speaker CDs which are available for rent for a nominal fee.
- We publish the newsletter, High Sobriety, sent at no charge to all <u>registered</u> San Mateo County A.A. groups and available by subscription to all A.A. members. Faithful Fivers receive a free copy as well.

Who pays for our Central Office? We, the members of A.A., do. Our Seventh Tradition states that we are self-supporting through our own contributions. Central Office also receives donations from individual alcoholics (such as through our Faithful Fivers program). Other sources include our annual anniversary party and income from the sale of A.A. literature.

Central Office is open Monday through Friday from 8:30 am to 4:30 pm.

STEP THREE: Made a decision to turn our will and our lives over to the care of God as we understood Him.

THE SPECTRUM OF BELIEF



The freedom of belief the program embraces has kept this agnostic sober for over three decades.

My wife came with me to my first meeting of Alcoholics Anonymous and thought I'd get up and walk out when she heard the 12 Steps and 12 Traditions read with their references to God. I was a cynical agnostic and she thought: "This won't work, it's too religious." But after my last binge a week before the meeting I'd tried to kill myself, so I was in no state to argue about "theological abstractions." I'd escaped death by a hair's breadth and that made me as "open-minded as only the dying can be." I listened with laser-like attention to what would keep me alive and filtered out things I heard that made no sense to me or with which I disagreed; I listened for the similarities, not the differences.

I took AA's first Step the morning I tried to commit suicide. I'd known for years that I had a serious drinking problem, but wouldn't admit I was powerless over alcohol. I'd tried every way I knew to bring my drinking under control; there was always "one more attempt—and one more failure," as the Big Book says. Finally, absolutely defeated, I knew I couldn't go on and decided to end it all. In a perverse way I thought it would also be best for my family; at least they wouldn't have to deal with a chaotic drunk in their lives any more. But they didn't want me to die – they just wanted me to get well, and I didn't know how to do that.

We're told that willingness, honesty and openmindedness are the essentials of recovery, and I made a start on Steps Two and Three by going to my first AA meeting. I came to believe that AA (a power greater than myself) could restore me to the sanity of not drinking, though at that stage it was more a desperate hope than a belief. In my own way I also decided to turn over my will and life to AA's care because I clearly couldn't care for myself when it came to stopping drinking. Bill W. said each member has the privilege of interpreting the program according to his or her own outlook and experience (As Bill Sees It). Even the pioneers who wrote the Big Book knew that none of them could 'maintain anything like perfect adherence' to the principles outlined in the Steps; they claimed progress, not perfection.

Bill W. paid tribute to atheists and agnostics in the early Fellowship who insisted on adding the crucial phrase, as we understood Him after the word God in the Third and Eleventh Steps. That ensured that all who wish to stop drinking may enter, regardless of their belief or lack of belief. The only requirement for membership is a desire to stop drinking (or, as in my case, to stay stopped); AA membership does not demand conformity to any idea, philosophy or religious faith. Certainly it does not require finding a personal God or I would have been smoke and ashes a long time ago.

After 31 continuously sober years in AA, I am still an agnostic. Whether or not a God exists is to me irrelevant; my primary purpose is to stay sober and, as far as I can, help other alcoholics to achieve sobriety. I lack the certainty to say there is no God and my nontheism is not atheism or anti-God. I pray and meditate, but I doubt very much that there is a supernatural ear listening. To me prayer is an act of humility. When I pray, I am saying I don't know all the answers and I need help.

My personal 'creed' encompasses the spectrum of belief and non-belief. I've found that the realm of the Spirit is indeed "broad, roomy and all-inclusive, never exclusive." For a one-time supercilious agnostic like me, that's good enough!

MESSAGE FROM GENERAL SERVICE:

Greetings district 05, aka San Mateo County. Agenda topics for the 2023 General Service Conference are out. The agenda topics are the vehicle by which the groups drive Alcoholics Anonymous. Concept 1 states "Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship". Our general services representative (GSR's) are a vital link in the process we use to govern AA. Our groups, through their GSR's, inform our general service conference of the desires of the fellowship as expressed by the group's responses to agenda topics, the group conscience. If a group chooses not to participate in general service that is their right. If not participating however the group has voluntarily given up its authority over the governance of the fellowship.

The experience in AA is that fewer groups are choosing to participate in general service. While this does not represent any "sky is falling" situation it does raise concerns as to if we are providing our general service conference with an accurate picture of the conscience of our "whole fellowship". There were changes made in our preamble and some of our literature recently and the feedback received by our General Service Office (GSO) indicated that many felt left out as the decision was made when some were not able to participate due to the pandemic. As a result, the changes were reviewed in 2022 and it was decided that they would remain.

This year there is an agenda item that ask AA as a fellowship to address the issue of if we should change any of the writings of our founders and if so what process should we use. This question is raised in Finance Item F and does not seek to make changes rather is seeking discussion and input to a question that many in the fellowship are very passionate about. As a reminder without group input via a GSR a group willfully chooses to let others decide the governance of Alcoholics Anonymous. I would encourage all groups to consider participating in general service and contribute to the collective conscience that drives our fellowship.

The position of District Committee Member (DCM) is one that this district, San Mateo County, has in my brief history, struggled to fill. We currently have two of nine DCM positions filled. This means our district is poorly represented at area functions and an important resource for our general service representatives is missing. The best DCM's are those who have served as a GSR and are willing to be service sponsors. We are reaching out to our previous GSR's to seek their assistance. As a note a DCM can either be elected by a subdistricts GSR's or appointed by the DCMC.

In an effort to address the immediate concerns of our representatives we will be initiating a Service Manual Study/Ask Your DCMC session starting at 6:15pm and end at approximately 6:45pm on the third Tuesday of the month. The meeting will begin with approximately 15 minutes of study from our Service Manual and then move to discussion of any issue anyone wishes to bring up, ask your DCMC. There will be no minutes kept so what is discussed is "off the record" and you need not be currently participating in general service to attend.


